

RELEASE, WAIVER OF LIABILITY, ASSUMPTION OF RISK, AND INDEMNITY AGREEMENT

READ THIS AGREEMENT CAREFULLY. THIS IS A FULL RELEASE OF ALL CLAIMS AND WAIVER OF IMPORTANT LEGAL RIGHTS.

THIS AGREEMENT is entered into by and between South Bay Polo, Inc., a California corporation (hereinafter "SBP, Inc.") and the person(s) identified on the signature page (hereinafter the "Undersigned"), and is effective upon said signature.

The Undersigned, on behalf of themselves, their guests, personal representatives, employees, contractors, heirs, successors, spouses, children, and assigns, hereby agrees to the following:

- I. Herschack Köline is a Dancerous Activity. The Undersigned acknowledges that the inherent risk in riding, working around heres, and playing polo are dangerous activities which involve a risk of serious personal injury, and in some cases, death. The Undersigned acknowledges the unpredictable nature and rirational behavior of horesse, regardless of their training and past performance, and the inherent dangers of comportion, including polo, schooling, and training of horess. The Undersigned also acknowledges the risk and danger of injury or death in the use of the horse(s) saddles, bridles, equipment, and gear. The Undersigned on behalf of him/herself and all others associated with him/her. Rowingly and intelligently assumss the risk and danger associated with horses and their activities, and declare that behse has the background and experience to intelligently accept responsibility for these risks.
- 2. Release. Discharge, and Promise Not to Sue. In consideration of using SBP, Inc.'s facilities, including participating in United States Plob Association (TUSPA)'s sanctioned polo tournaments, the Undersigned releases, discharges, and promises not to use SBP, Inc. or USPA, or any of its owners, Officers, employees, agents, subcontractors, and assigns from any and all loss, liability, claim, damages, or costs, of any nature or kind, including attorney fees, arising out of or in any way related to any loss, damage, injury, including death, to personship, poperly, horsets, if family results, in any way, from any activity that occurred on or adjacent to the results, in the contraction of the property of the p
- 3. Indemnity and Hold Harmless. The Undersigned agrees to indemnify, hold harmless, and defend SBP, Inc. and USPA from any and all claims of any nature or kind which arise or might arise or that are in any way connected with the Undersigned, for any loss or damage, directly or indirectly related to the Undersigned's participation or use of any of the facilities of SBP, Inc.. It is the intention of the parties hereto that the Undersigned's uniformity, hold harmless, and protect.

SBP, Inc. and USPA from any claims brought by the Undersigned or anyone associated with them who brings any claim, lawsuit, or cause of action against SBP, Inc. or USPA that arises, in whole or in part, from the alleged negligence of SBP, Inc. or USPA, or as the result of the use of any of the facilities, regardless of cause. This indemnity shall include the obligation of the

Undersigned to defend SBP, Inc. against any and all claims, including reimbursing SBP, Inc. for attorney fees, upon SBP, Inc. 's demand, for lawyers of their own selection to defend any claim or serion brought against them.

- 4. Rules and Regulations. The Undersigned agrees to abide by all Rules and Regulations of SBP, Inc. and USPA. The Undersigned acknowledges that the use of the SBP, Inc. facilities is at their own risk. The Undersigned warrants that her or she is physically and mentally fit to participate in competitive activities and gives consent to SBP, Inc. for emergency medical treatment in the event of injury to the Undersigned or verteinary care for hisher animals.)
- 5. General Provisions. This is the entire agreement between the parties and may only be anneaded in writin, signed by all the parties. California as whall govern this Agreement, and venue shall be the Superior Court, City of Gilityo, California. In the event of a dispute arising out of this Agreement, and the prevailing party shall be entitled to attempt fees and costs. This Agreement may be signed and transmitted by facsimile or electronic mail, and the signature(s) and initials shall be deemed for all provises originals.
